


Wiring & Installation Diagram for SSR-3 Solid State Relay




Wiring & Installation Diagram for SSR-3 Solid State Relay

Typical Wiring Diagrams SSR-3: Providing Pump-Up/Pump-Down Control




<u>Refill</u>: Low level permits S2 to close, starting refill pump. Rising level allows S2 to open and eventually closes S1 to actuate the SSR-3 "OFF" circuit and stop the pump motor. The SSR-3 "OFF" override assures pump shut-down even if S2 failed to open.

Pump-Down: with "ON" and OFF" connections of S1 and S2 transposed at the SSR-3, the pump is started by S1 and stopped by S2 at low level. The same "OFF" override prevails.




